- 9.1.1 Review of the Road Safety Strategy: The Way Forward

Roddy MacIntyre, Manager, Traffic Services and Road Safety gave a presentation, seeking feedback from the Committee on the Road Safety Strategy, and responded to questions of clarification from the Committee.

Active Transportation Advisory Committee at Draft Minutes

May 16, 2024

The Committee noted the following:

- Inclusion of standards and measured data on intersections for walking, biking, and driving
- Provincial amendment to the *Nova Scotia Motor Vehicle Act* on approving jurisdiction autonomy to the Municipality
- Provincial approval on red light signals, photo radar pilots, summary offense tickets, reducing speed limits to 40 km/per hour within residential communities
- Mandate on accessing intersections, restricting right turn on red lights, better road signage, intersection design, and road sign education
- Road maintenance, near miss data collation, and encroachment/detour on sidewalks
- Concerned with the length of time between road safety reviews

MacIntyre spoke to Key Performance Indicators being used to ensure safe driving within the community and working on legislation changes with the Province.

9.1.2 Active Transportation Update

David MacIsaac, Manager, Active Transportation gave an update on the May 29, 2024 public engagement session on AAA bikeway connections in Dartmouth, engagement sessions planned for the summer on the Alderney Drive functional plan, Grahams Grove, Penhorn, Westphal, and Main AT Connections Project. Staff was also conducting neighbourhood engagement on sidewalk development at Astral Drive and Tremont Drive.

MacIsaac spoke on forthcoming reports to Halifax Regional Council respecting the potential for a new active transportation crossing on Highway 101 at Exit 2, and the Rural Active Transportation Program. MacIsaac noted staff was working on getting approval for an interim improvement to the street bike lane, and the AT Capital Grants Program. MacIsaac responded to questions of clarification from the Committee.
